



END USE/END USER CERTIFICATION

RE: COMPLIANCE WITH UNITED STATES AND EUROPEAN UNION EXPORT REGULATIONS

It is the policy of **BRITISH INTERNATIONAL INDUSTRIES** to verify the end use and end user in the sale and/or exchange of all products to ensure compliance with applicable EU and US export control laws, sanctions and regulations.

Please confirm the following:

1. I (We) will abide by all applicable EU and US export control laws and regulations for any products purchased and/or exchanged from British International Industries and will obtain any licenses or prior approvals required by the respective government prior to export or re-export of products purchased and/or exchanged from British International Industries.
5. I (We) will not permit the export, re-export, or transfer (in country) of any products purchased from and/or exchanged from British International Industries to be used in activities prohibited by EU or US laws or regulations or for military end use or by military end users listed by Department of Commerce, Bureau of Industry and Security (BIS).
6. I (We) agree to be bound by the export control requirements in No. 1-5 above and further agree that such requirements shall survive the completion, early termination, cancellation or expiration of the applicable purchase order, agreement, or contract.
